##### a. Audit results of the Company's financial situation in 2024

- Accounting work such as recording, storing documents and preparing accounting books and financial reports has been fully and honestly performed.

- Business activities in the third quarter of 2024 recorded a pre-tax loss of VND 2,5 billion. However, the company's financial health is still maintained and guaranteed to be safe and stable. The company did not incur bank loans or financial leases during the period.
- The Company has prepared and published the audited 2023 financial statements, quarterly financial statements and semi-annual audited 2024 financial statements in accordance with the accounting regime, accounting standards and current legal regulations. Fully comply with accounting-related work, ensuring the principles of honesty, prudence and reasonableness.
- Through monitoring and evaluating the independence and objectivity of the auditing company, the Audit Committee agrees with the data on the audited 2023 financial statements and the audited 2024 semi-annual financial statements of the Board of Directors.

b. The Company's compliance with the law and the management of the Board of Directors in 2024

- The Board of Directors has paid dividends to shareholders according to the resolution of the 2024 Annual General Meeting of Shareholders, including 5% cash and 5% shares, and completed the listing procedures for 3.165.962 shares to pay dividends for 2023. Ensuring full rights and benefits for shareholders.
- The Board of Directors has successfully implemented the Resolutions of the General Meeting of Shareholders and performed its functions and duties in accordance with the provisions of law and the Company's Charter. The Board of Directors has fully implemented the Resolutions of the Board of Directors.
- Although the business results in the third quarter of 2024 did not meet expectations, the Audit Committee still highly appreciated the management efforts of the Board of Directors in the context of a very difficult business environment as in the last 6 months of 2024. The company's financial situation is still maintained and ensured to be safe and stable. The company did not incur bank loans or financial leases during the period.

4. The coordination among Audit Committee, the Board of Management, Board of Directors and other managers:

- In 2024, the Board of Directors fully performed its functions and duties, making important decisions on development orientation in accordance with the provisions of law and the company's charter. The members of the Board of Directors fully participated/authorized in direct meetings and gave written opinions on issues under the authority of the Board of Directors with a high sense of responsibility.
- The Audit Committee was invited to attend all regular Board of Directors meetings in 2024, was fully and promptly reported on the actual business performance of the company, and provided comments based on its expertise to the Board of Directors and the Board of Management to contribute to the Board of Directors' decisions. In addition, the General Director and the Audit Committee regularly exchanged opinions during the operation to adjust unreasonable issues in terms of operational control as well as financial work.
