3. Supervising the the Executive Board by the Board of Directors:

Under its roles, authority, and responsibilities, the Board of Directors has strengthened and effectively carried out the supervision of the Executive Board to ensure the Company's operations are safe, compliant with legal regulations, and aligned with the resolutions of the General Meeting
