**Explanation:**

In 2023, the sales volume was 13,448.4 tons, with an average selling price of 34,572,422 VND/ton.

In 2024, the sales volume was 11,929.53 tons, with an average selling price of 48,023,588 VND/ton.

Due to:

- + The sales volume in 2024 is lower than in 2023, but the average selling price is higher in 2023. (The average selling price in 2024 increased by 13,451,166 VND/ton, or an increase of 38.91% compared to 2023).
- + Profit from business operations in 2024 increased by 45,901,623,657 VND, or a 16.85% increase compared to 2023.
- + Other profits in 2024 increased by 27,822,201,695 VND, or an 88.39% increase compared to 2023.

Therefore, profit after tax in 2024 increased by 70,150,100,811 VND or 27.61% compared to 2023.
