Thong Nhat Rubber Joint Stock Company would like to explain the business results for Q1 2025, with changes in after-tax profit from corporate income tax increasing or decreasing by 10% or more compared to the same period last year as follows:

1	Total revenue and other income	35,017,583,407	42,587,307,654	(7,569,724,247)	82.2%
2	Net profit after corporate income tax	6,986,797,223	4,067,429,562	2,919,367,661	71.7%

The after-tax profit for Q1 2025 reached VND 6,986,797,223, an increase of VND 2,919,367,661 compared to Q1 2024, corresponding to an increase of 71.7%. The reason for this is that in Q1 2025, the selling price of bananas increased compared to Q1 2024, leading to a rise in profits from banana production and business activities, with the corresponding increase being VND 3,518,634,209.
