1. The AGM approved the 2019 BOD report and plan for 2020.

3. The AGM approved the audited financial statements in 2019.
4. The AGM approved the 2019 business result:
  - Total revenue: 1,934,735,052,825 dongs
  - Profit before tax: 177,377,521,967 dongs
  - Profit after tax: 140,546,590,989 dongs.
5. The AGM approved the 2019 profit distribution:
  - Profit after tax of 2019: 140,546,590,989 dongs
  - To distribute funds: 40,758,511,387 dongs, including:
    - Investment and Development fund (20% profit after tax): 28,109,318,198 dongs
    - Reward and Welfare fund (8% profit after tax): 11,243,727,279 dongs
    - Bonus to the Executive Board (1% profit after tax): 1,405,465,910 dongs.
  - To pay cash dividend for 2019 (30% charter capital): 78,622,749,000 dongs
    - To pay first dividend for 2019 (10% charter capital): 26,207,583,000 dongs
    - Additional dividend for 2019 (20% charter capital): 52,415,166,000 dongs.
  - Undistributed remaining profit after tax of 2019: 78,391,312,242 dongs; of Which:
    - Remaining profit of 2019: 21,165,330,602 dongs
    - Undistributed accumulated profit before 2019: 57,225,981,640 dongs.
6. The AGM approved the 2020 business plan:
  - Total revenue: 1,850 billion dongs
  - Profit before tax: 150 billion dongs
  - Profit after tax: 120 billion dongs.

7. The AGM approved the 2020 profit distribution plan:
  - Expected dividend: from 25% to 30%/charter capital
  - Payment form: cash or stock
  - Reward and Welfare fund: 8% profit after tax;
  - Investment and Development fund: 20% profit after tax;
  - Bonus fund to the Executive Board: 1% profit after tax.
8. The AGM approved the remuneration of the BOD, Supervisory Board in 2019:
  - BOD: 4,210,926,570 dongs

9. The AGM approved the plan for remuneration of the BOD, Supervisory Board in 2020:
