Subject	Explanation for separate FS Q4.2020

Content:

Sai Gon Thuong Tin Commercial Joint Stock Bank has explained the separate financial statement for Quarter 4/2020:

- Profit after tax of Q4.2020 was 765.4 billion dongs, increased by 190.3 billion dongs (+33.1%) compared to the Quarter 4/2019 due to the following reasons:
 - a. Net profit increased by 1,195.1 billion dongs because:
 - ✓ Profit increased by 686.6 billion dongs.
 - The lending balance increased by 49,999 billion dongs, so the gain from lending increased by 726.8 billion dongs;
 - The deposit at credit decreased compared to the same period of last year, so the gain from deposit decreased by 96.3 billion dongs;
 - The debt securities investment increased by 5,373 billion dongs compared to the same period of last year, so the gain from debt securities investment increased by 33.2 billion dongs;
 - Other gains increased by 22.9 billion dongs.
 - ✓ Expenses for deposit and borrowing decreased by 508.5 billion dongs.
 - The deposit balance at the year-end increased 31,317 billion dongs compared to the same period last year, but the average balance of Quarter 4/2020 decreased compared to the Quarter 4/2019, so the interest expenses decreased by 481.7 billion dongs;
 - The average borrowing in Quarter 4/2020 decreased compared to the same period of last year, so the expense for borrowing decreased by 10.4 billion dongs;
 - Other expenses decreased by 16.4 billion dongs.
 - b. Other income increased by 27.4 billion dongs. In particular, the income from service activities decreased by 134.5 billion dongs; income from securities trading increased by 100.9 billion dongs, income from the other activities increased by 19.2 billion dongs,

- income from the foreign exchange trading increased by 63.1 billion dong; to contribute capital for buying shares decreased by 21.3 billion dong.
- c. Other expenses increased by 1,032.2 billion dong. In particular, the provision for credit decreased by 448.7 billion dong; the operating expense increased by 1,440.3 billion dong; the corporate income tax expense increased by 40.6 billion dong.
- Therefore, $(a) + (b) - (c) = 190.3$ billion dong.
