## **LISTING AND OFFICIAL STOCKS TRADING OF CLEVER GROUP JOINT STOCK COMPANY (ADG)**



On 22<sup>nd</sup> February 2021, Ho Chi Minh Stock Exchange (HOSE) held a ceremony to celebrate the listing decision and put **18,000,333** shares of Clever Group Joint Stock Company (Stock code: **ADG**) into trading. The total value of ADG listed shares reached **180,003,330,000 VND**, the reference price on the first trading day was **64,900 VND/share**, the price fluctuation band was +/- 20%.

Clever Group Joint Stock Company (Clever Group) officially operated since 08/2008 with the charter capital of 400 million VND. After many adjustments, the current charter capital of the Company has reached over 180 billion VND. The main areas of Clever Group's business activities are information technology services and other services related to computers, advertising and management consulting activities. According to the consolidated financial statements in the prospectus of the Company, in 2018 and 2019, Clever Group's net revenue reached over 335 billion VND and 362 billion VND; equivalent to profit after tax of 20 billion VND and 40 billion VND, respectively.
